5. Amendments:

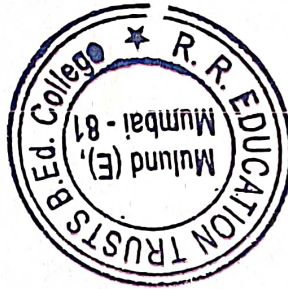
Any amendments or modifications to this MOU must be made in writing and signed by authorized representatives of both parties.

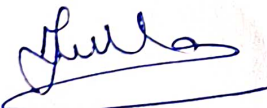
