Termination:

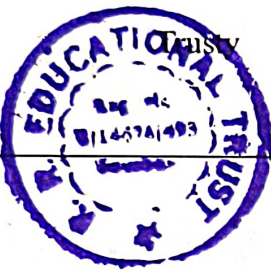
Either party may terminate this MOU with written notice if the other party breaches any material provision herein.
