This has reference to your application dated 30th October, 2003, for
affiliation of a new college for Education (B.Ed.) proposed to be started at
Mulund (East), Mumbai from the academic year 2004-05.

In this connection, I am directed to inform you that considering the
permission granted by the Government of Maharashtra to your Trust as per
the letter referred above, the Ag.Vice-Chancellor under the powers conferred
upon him under Section 14(7) of the Maharashtra Universities Act, 1994 has
granted the permission for first time affiliation to your Trust to open a new
college of Education (B.Ed.) at Mulund(East), Mumbai, on permanently 'No
Grant Basis' from the academic year 2004-05 to start the B.Ed. Degree
Course with intake capacity of 100 students.

The college has to fulfill the conditions mentioned in the letter under
reference, issued by the Regional Director, National Council for Teacher
Education, Bhopal.

The college has also to fulfill the following affiliation conditions -

- (1) that the conditions laid down by the University from time to time.
- (2) that the minimum attendance of all the students must not be less than
75% during the academic year and college will have to complete
syllabus of all the subjects during the academic year.
